

**Silver Wing Script Services (“Silver Wing”)
Submission Release Form**

1. The writer(s) understand that Silver Wing and its operator (hereby known as “Analyst”) will not review any work without this signed Release Form.

2. The writer(s) hereby grant Silver Wing the right to read and evaluate the accompanying screenplay material (the “Material”), entitled: _____ . The writer(s) acknowledge that the Material was written by them(self). The writer(s) also acknowledge that they are the sole owner(s) of this work and its copyright.

3. The writer(s) agree and understand that Silver Wing and the Analyst become privy to many literary materials, scripts and ideas, and Material may be similar/identical in nature, theme, idea, plot, format and/or other respects to said materials received and/or created by the Analyst. Writer(s) agrees to hold harmless the Analyst from any similarity between the Material and any other script the Analyst receives, creates or has created. Writer(s) hereby releases the Analyst from any and all claims, liabilities and demands that may be made by the writer asserting that the Analyst has used or appropriated the Material, or any portion thereof. Writer(s) further agrees he/she/they will not be entitled to any compensation because of the use by the Analyst of such similar material, which may have been independently created by the Analyst or have come to the Analyst from any other independent sources.

4. The writer(s) acknowledge that Silver Wing recommends that all Material be copyrighted with the United States Copyright Office and/or registered with the Writer's Guild of America. The writer(s) also acknowledges that it is their responsibility to copyright or register the Material prior to submitting to Silver Wing and hereby releases Silver Wing from any claims that arise from my failure to do so.

5. The Analyst agrees that all analyses shall be kept strictly confidential and shared only with the writer(s). Analyses will not be shared or passed on to any agent, producer or other film production entity without the express written consent of the writer(s); however, writer(s) agrees that by submitting the Material to the Analyst, the Writer is not entering into any legal fiduciary relationship with the Analyst. Analyst maintains that copies of analyses will be kept for archival/reference purposes.

6. The writer(s) agrees that he/she is submitting Material to the Analyst for analysis services as outlined herein and within the website www.silverwingscripts.com. The writer(s) understands and agrees that literary service is a subjective service, that comments to the writer's Material may not be complimentary or positive, and that the Analyst cannot be held liable for any unfavorable comments made in any ordered analysis, and that the evaluation fee is non-refundable.

7. The writer(s) represents that the writer(s) is/are at least eighteen (18) years of age, and that they hold all legal rights to the Material enclosed or has the express consent of the writer(s) to send this material for analysis. The writer(s) further represents that the writer(s) knows of no encumbrances to the script and has not knowingly infringed on any copyrights or trademarks, and that he/she shall indemnify the Analyst from any liabilities, losses, claims, demands, costs or expenses should said infringements occur.

8. The Analyst hereby waves all interest in the submitted Material, in any and all media, throughout the universe in perpetuity. Should the writer(s) choose to implement any of the Analyst's ideas or suggestions they become the full property of the writer(s).

9. The writer(s) represents that the enclosed Material is not the only copy of the material. The writer(s) has/have retained a copy of the script. The writer(s) agrees that the Analyst cannot be held responsible for lost or damaged scripts.

10. The writer(s) agrees that they are submitting Material freely, for analysis services only, not for sale or representation, or for assistance with gaining a sale or representation. Writer(s) further agrees that the Analyst may refuse service to anyone, at any time, for any reason.

11. Writers who wish that their Material be returned are required to include a self-addressed, stamped envelope with their submission or will be charged a predetermined shipping fee.
